This is stemming from the fact that County's have not received per capita for over a year. I just received an email saying that we are going to receive per capita from February to December 2023. Which will definitely help out working capital.

Starting as of July 1, 2024, which is the Legion Membership year of 2025, all County per capita money will be sent directly to the County Treasurer and not through MyLegion or using the mail service. Also remember that the National dues will be increased by \$5.00 to \$0.00. That makes sending through MyLegion or snail mail \$0.00. The Department of New York will be notifying National to remove all County per capita from the MyLegion submission.

#### By MyLegion

- 1. Post will submit through MyLegion the membership that has paid their dues.
- 2. When submitted a copy of the transmittal slip will be sent to the County Treasurer along with a check payable to the Nassau County American Legion in the amount of \$2.50 for each name on that transmittal.



The Department of Veterans Affairs proposed new rules that would expand Agent Orange conditions to some locations and times in 12 U. S. States and locations in Canada and India. The Biden administration is waiting for congress to approve the additions.


